- ☐ Registered Filing Agent
- ☐ Approved Company Name
- ☐ One Resident Director
- ☐ Minimum paid-up capital (\$1)
- ☐ Registered Physical Business Address

- ☐ Appoint a Corporate Secretary
- ☐ Decided Financial Year-End
- ☐ Other documents specified by ACRA
- ☐ At least one shareholder
(Can be 100% foreign owned)

By appointing a **Registered Filing Agent**, you can let them handle the rest of your incorporation filing instead of preparing everything else on the list yourself

Company Audits in Singapore

Exemptions

Small companies and **Small groups** that satisfy any 2 of these conditions:

- Annual revenue \leq \$10 mil
- Total assets valued at \leq \$10 mil
- \leq 50 employees

And **Dormant Companies** that

- Have been dormant from formation or-
- Dormant since the end of their previous financial year

Requirements

- Companies must appoint at least one auditor within three months of incorporation
- Auditors must report on the company's financial statements
- Companies must disclose auditor remuneration in a general meeting
